My perspective regarding your reply to Robert Kennedy jr.

Dear health minister Mrs. Warken,

may I shortly introduce myself: My name is Dr. med. Bianca Sabine Witzschel, PhD, medical specialist in clinical pharmacology and toxicology, as well as medical specialist in general medicine. I earned my PhD on the topic of proving Primidon (Desoxyphenobarbital) in blood and saliva.

It is about to happen this week that I am being sent to penitentiary Chemnitz, Germany, for a scheduled period of 1 year and 4,5 months – the complete duration of my sentence comprises 2 years and 8 months, of which I have already spent 476 days in investigative custody.

As I'm personally affected by the topic I have read the writing of the American health minister Robert Kennedy jr. - as well as your reply to it.

Perhaps you might lack knowledge about the reasons for me having been sentenced, therefore I feel a need to inform you accordingly.

In the years of 2020 and 2021 I certificated attestations on my patients' being excepted from the public demand of wearing a face mask, of doing PCR tests and of being vaccinated.

Everyone of my patients had to fill in a complete sheet of amnonesis (parents on behalf of their children) and sign it. Furthermore there were partially more details added while having a personal consultation for counselling afterwards. We then did bioresonance analysis, clarifying the content of the attestation, which was finally handed over.

On 1st February 2022 I became deprived of my licence to practice. 1 year later, on 28th February 2023 I faced my 5th house search – at 6 a.m. I was brutally ripped out of my sleep by many officers, and I got arrested.

They summoned me at the custodial judge and later transferred me to the Chemnitz prison.

In November 2023, 40 scheduled court hearings commenced at the maximum security prison in Dresden. During the rides between the Chemnitz prison and the maximum security prison Dresden, Hammerweg, I was handcuffed and shackled.

In the maximum security prison Dresden I remained in handcuffs and tied to an officer leading me along, until arrival at my courtroom chair, amidst both of my advocates, and only then my handcuffs were removed.

I was held in custody for 476 days. After having been sentenced on 17 th June 2024, I was at first allowed to return home – under massive constraints.

My appeal on points of law at the Federal Constitutional Court was rejected in August 2025. On 22nd January 2026 I received order by prosecution Dresden to commence serving my sentence within a period of two weeks after receipt of the order, which means that this is due to take place this current week.

I'm furthermore threatened by additional sentences, as there are to follow more trials based on similar accusations. Apart from the fact that I attested the certificates mentioned above I was accused to be a right-wing-extremist, and after during one of my house searches an evidently non functional flash light had been found, which in emergency cases might have had a teaser function, I am even being accused for illegal gun possession.

I cannot tell otherwise, that sort of framing that I was a right-wing extremist „Reichsbürger“ was drawing a red line through the complete trial and most obviously just serving the purpose to discredit me. So far some basic information. Now I would like to return to the topic of attestations certified by me.

While acting out my profession I have been in the position to accumulate knowledge, enabling myself to think in a self-determined way.

FFP2 masks are not suited to repel viruses and do not offer any protection against mutual infection – as proof you may well consult any data-sheet available covering the topic – even if issued in pre-Corona times.

In contrary these FFP2 masks were originally created to offer protection against dust and are therefore made of quite airtight material.

FFP2 masks are in no way medical products and accordingly did not have to undergo any likewise testing. These are so called „dust masks“ which are to be worn under certain conditions only:

90 minutes without a break
then a break of 30 minutes has to follow
and the mask has to be changed.

Wearing the mask leads to rebreathing and in consequence to an increased level of CO₂ in blood, which – in every human – causes acidosis – may the person be sick, healthy, young or old – and primarily symptoms are about to effect the brain.

By moisture and the warm milieu under the masks, oral mucosa is in danger and possible results might be respiratory infection and dermatosis.

Wearer of glasses face additional risks by condensation, which might lead not only to concentration difficulties but also generates increased likeliness of accidents occurring.

As well the psychic load must not go unspoken, as so many people had been forced against their will to wear this kind of masks.

In case of small children these were not able to read their mothers' facial expression while the mother wore a mask. This fact can be considered as a very heavy burden and in no way suited to serve the overall development of the child.

According to my attitude as a PhD, every single one of the arguments listed above makes an indication for a medical mask certificate – as well concerning seemingly healthy persons, for the purpose of avoiding danger and damage to their health.

The certificates limiting the sort of SarsCov2–tests to spitting tests only are as well fully justified, as they produce results which do not differ in any way from the results of the ordinary tests, while spitting tests prevent injuries by the diagnostic dipstick.

Finally let me point out that my exemption certificates on vaccinations were indeed suited to save many people – of minor as well as of good health - from the already proven side effects caused by the injections („vaccines“) which turned out to have had no sufficient testing.

Furthermore I was accused of having obtained money by fraud – by simply doing these certificates, by handing them out to masses of people consulting me and even of having prepared these certificates in advance from home.

Apart from the fact that I never accepted all these increased medical fees I cannot understand at all what exactly should be unlawful about the fact that I had been doing these certificates by myself, as I had no receptionist available and therefore was preparing printouts in advance at the praxis computer, These prepared documents were based upon according appointments and handed out to the patients only after the consultation - always personally.

One may also not criticise me for testing my patients by a bio-resonance unit – as for this sort of certificate neither examinations are being demanded, nor certain methods.

I did not do health certificates.

Among the alternatively thinking medical doctors there is an established attitude about bio-resonance diagnostic equipment being a practicable and well suited examination method, which is certainly more informative than – if even ever done – so called examinations for danger prevention made by medical doctors in vaccination centers.

As a PhD I have always been acting and deciding on behalf of my patients, for I have sworn an oath to which I strictly adhere to.

To clarify this statement I recite the wording as follows:

WMA declaration of Geneva

The Physician's Pledge

AS A MEMBER OF THE MEDICAL PROFESSION:

I SOLEMNLY PLEDGE to dedicate my life to the service of humanity;

THE HEALTH AND WELL-BEING OF MY PATIENT will be my first consideration;

I WILL RESPECT the autonomy and dignity of my patient;

I WILL MAINTAIN the utmost respect for human life;

I WILL NOT PERMIT considerations of age, disease or disability, creed, ethnic origin, gender, nationality, political affiliation, race, sexual orientation, social standing or any other factor to intervene between my duty and my patient;

*I WILL RESPECT the secrets that are confided in me, even after the patient has died;
I WILL PRACTISE my profession with conscience and dignity and in accordance with good medical practice;
I WILL FOSTER the honour and noble traditions of the medical profession;
I WILL GIVE to my teachers, colleagues, and students the respect and gratitude that is their due;
I WILL SHARE my medical knowledge for the benefit of the patient and the advancement of healthcare;
I WILL ATTEND TO my own health, well-being, and abilities in order to provide care of the highest standard;
I WILL NOT USE my medical knowledge to violate human rights and civil liberties, even under threat;
I MAKE THESE PROMISES solemnly, freely, and upon my honour*

The central principle of medical ethics reads as follows:

Primum non nocere – at first do not cause any damage!

Dear Mrs. Warken,

I grew up in the DDR, where I got to know a regime of injustice. It is with endless pain I feel right now, that the Federal Republic of Germany might be about to take the same road as the DDR did in the past.

But I wish to tell you one thing: We, the East German „Ossis“ have not forgotten about how important it is to stand firm with ones own opinion and also to stand in for it.
